William P. Condra, one of Miller County's pioneer and highly honored citizens, died at his home near Iberia Monday, at the age of 87 years, 7 months and 11 days. He had been in failing health for several years and for the past few months was confined to his bed.

William Plumlee Condra was born in Tennessee near Nashville March 22, 1843. With his people he went to Illinois and about the year 1866 he came to Missouri. He was married to Melissa Ann Miller on Nov. 1st, 1885, near Iberia.

Mr. and Mrs. Condra's home was blessed with six children, all living. Clint, Fred and Arch of Iberia, Frank of Roswell, New Mexico; Wesley of St. Louis, Mo. and one daughter, Mrs. Norma West of Memphis, Tennessee.

Mr. Condra leaves two brothers and one sister, namely: David and Charles of Iberia and Mrs. Jennie Murphy of Dixon, Mo. Mr. Condra came to this community about 60 years ago and has lived on the same place for 55 years.

Funeral services were conducted Tuesday afternoon at 2:00 o'clock by President G. Byron Smith of the Junior College and two beautiful song selections were rendered by Misses Ruby and Lela Keeth, after which interment was made in the Iberia Cemetery under direction of Adams & Casey, local undertakers. Both brothers and sister and all the children, except Frank of Roswell, New Mexico, were present.

Death again has invaded one of our homes and claimed an aged and highly respected neighbor and friend, in the person of Mrs. Melissa Condra. Mrs. Condra, who has been an invalid for the past few years, fell and broke her hip Sunday, August 8, and this injury together with other ailments weakened her condition and she passed away at her home here near Iberia early Tuesday morning, shortly after midnight.

Melissa Miller was born in Williamsport, Penn., February 3, 1856. She entered into rest at 12:15 a.m. August 17, 1937, at the age of 81 years, 6 months and 14 days. She came to Miller County with her parents when a young

girl and on November 1st, 1885 she married William P. Condra who preceded her in death on November 2, 1930. To them was born six children, all of whom were at her bedside when the end came—they are, Clint, Fred, Arch and Wesley of Iberia, Frank of Roswell, New Mexico, and Mrs. Norma West of St. Louis. Those surviving, besides the children, are—one brother of Kansas and one sister of Pennsylvania, also four grandchildren, Therman, Russell and Cleora Condra and Carl West, besides many other relatives and friends.

Her life was true to the way she lived from day to day—a true and faithful wife, a kind and devoted mother and a friend and neighbor that shared the respect of every one of her community.

Funeral services, conducted by Rev. H.C. Wigger, pastor, were held from the Baptist Church here Wednesday morning at ten o'clock and interment was made in the Iberia Cemetery.

"Grandma" Goforth Dies in Waynesville – Mary A. Condra was born in Clay County, Tennessee November 10, 1844; was married to Frederic Seigle in 1860 to which union was born one daughter, Mary E. Huff, who is now at her home in Hickory County suffering with paralysis. Mr. Seigle went to war and in a few months was sent home sick, dying in a short time after his return. In 1866 she was married to David I. Goforth and to this union were born seven children—three girls and four boys, two of whom, A.M. and James, were present at the funeral services Tuesday.

She and her husband came to Miller County in 1883, where she lived until last January a year ago, when she was removed from her home here in Iberia to the home of her son, A.M. Goforth, in Waynesville, Pulaski County, after suffering a stroke of paralysis from which she never recovered.

She died Monday, July 16, 1923, at the age of 78 years, 8 months and 6 days. The body was brought to Iberia Tuesday for burial. Funeral services, conducted by Rev. H.J. Fenwick pastor of the M.E. Church, were held Tuesday afternoon at the home of D.H. Condra, brother of the deceased after which interment was made in the town cemetery by the side of her late husband under direction of Adams & Casey, local undertakers.

She leaves to mourn her loss several children among whom are A.M. of Waynesville, James of Wet Glaize, Camden County, Bob and Jack who live in South Dakota, and Mrs. Dave Johnston; also three brothers, W.P., D.H. and C.W. Condra, all of Iberia.

Mrs. Dave Condra, widow of the late David H. Condra of Iberia, passed away last Thursday at the home of her daughter, Mrs. Robert Rice in Springfield, Mo., with whom she had been making her home during her long illness. About 18 months ago she underwent a major operation in the amputation of her leg, due to an infection which spread over the entire limb. Later she suffered a stroke and her condition gradually grew worse until the end.

Mrs. Condra was one of Miller County's most highly esteemed women. She and her husband reared their family on a farm near Iberia and their memory is highly cherished by many of the Sentinel readers.

Obituary:

Emma Smith Condra passed away in Springfield Thursday morning, June 22nd at the age of 73 years, 2 months and 20 days after a lingering illness. She was the last survivor of a family of six children.

Mrs. Condra was born in Pulaski County not far from the present site of Iberia and spent all her life in Miller and Pulaski Counties with the exception of the last year and a half when she made her home with her daughter, Mrs. Robert Rice, 936 North Campbell, Springfield, MO.

At an early age she affiliated with the Iberia Christian Church and on November 1??1 (copy not clear) she was united in marriage with David H. Condra, one of the pioneer settlers in the Iberia community. Mr. Condra departed this life March 31, 1931.

Surviving are two sons, Everett A. Condra of Jefferson City, Clate Condra of Iberia, and one daughter, Mrs. Robert E. Rice of Springfield as well as nine grandchildren and two great-grandchildren.

Funeral services were held at the Adams & Casey Funeral Home in Iberia Saturday afternoon with Rev. W. E. Wadell (? copy not clear) of Crocker officiating. Burial was in Iberia Cemetery under direction of Adams and Casey Funeral Home.

A 2-car collision in which police estimated one of the vehicles was traveling more than 100 miles an hour killed three men early today on I-35 at Liberty. Killed were John Henry Koegler, Jr., 22 years old, driver of one of the cars; Henry Loy Owen, 21 a passenger in Koegler's car, and Robert Allen Condra, 38, the other driver, all of Liberty.

Robert Fitzgerald, Liberty patrolman, said the Koegler car was northbound on I-35 at a speed estimated at more than 100 miles an hour when it struck the right side of the car driven by Condra, who was attempting to turn left from the southbound expressway lane at the main entrance of the Wilshire addition.

Fitzgerald said the Condra vehicle was hurled 220 feet by the impact. Koegler's car continued north and veered into a field. No skid marks were visible on the pavement, officers said, but gouge marks in the concrete marked the point of collision in the center of the right-hand northbound lane. Both vehicles were equipped with safety belts, but police said none was in use.

Koegler, an employee of the Ford Motor Company assembly plant at Claycomo, had gotten off work shortly before the crash, about 2 o'clock this morning. Owen was dead at the scene. Condra was pronounced dead at the North Kansas City Memorial Hospital and Koegler died a few minutes after reaching the hospital...

Condra, who was to have celebrated his 38th birthday anniversary today, was a sanitary engineer for the Buchanan County-St. Joseph, Mo., Health Department. He was born in Iberia, MO., and was a veteran of World War II.
