Mrs. Mary Flaugher, widow of James Flaugher, and a resident of Tuscumbia and community all her life, passed away at her home here at 8:15 O'clock Monday night following only a few days' illness. Mrs. Flaugher became ill last Friday night and by Saturday afternoon her illness was so acute that she did not recognize anyone. Her illness was thought to have been intestinal flu.

She was born in Miller County April 14, 1865, and had she lived until next April would have been 80 years of age.

At about the age of 23 she was united in marriage to James Flaugher and to this union seven children were born, two of whom Mrs. Manley Renfrow, who died in 1936, and Everett, who died in infancy, preceded her in death. Her husband passed away July 28, 1930

Mrs. Pearl Flaugher of near Tuscumbia was injured fatally, her husband William Flaugher was severly hurt and one driver was arrested as teh result of a four-automobile accident on Highway 54, at Aurora Springs yesterday. Charges of careless and reckless driving have been placed against John F. Taylor of Richland, the state patrol office here said.

Mrs. Flaugher died in St. Mary's hospital here shortly afternoon, three hours after she had sustained a fractured skull in the wreck. Her husband, who also was rushed to the hospital here by ambulance, still is a patient. He sustained a broken leg and lacerations on his face.

State patrolmen said the tragedy occurred when Taylor, who was driving a 1937 Dodge sedan, attempted to pass another car on the steep hill at Aurora Springs, two miles south of Eldon. Officers said Taylor applied his brakes when he found himself facing an approaching car. His sudden effort to stop threw Taylor's car across the road where it struck a 1937 Chevrolet being driven by Morris E. Harrison of Fulton, patrolmen said. The Harrison car in turn struck a 1931 Ford in which Mr. and Mrs. Flaugher were passengers.

On Monday, April 24, 2006, Ms. Helen will turn 90 years old. To celebrate this tremendous milestone, her family threw what was supposed to be a "Surprise" 90th birthday party in her honor, but news travels fast in a small town. She has devoted her life to her wonderful family which has now grown to approximately 125 descendants.
