Harold Flaugher is our newest board member, hailing from Rocky Mount. He and his wife, Joy, have been part of the 'Monday group' of volunteers for the past year. He is a historian by nature and a very valuable resource for questions regarding Miller County's history and early citizens. He is also very knowledgeable regarding antique farm tools and helps with identification in that area.

He made regular trips to the museum during our construction phase in 2007-2008, often bringing artifacts to add to the displays. He recently did the hard work of moving the heavy tombstones of John and Mahala Williams to the museum front porch so they could be preserved after they were replaced with new monuments. Greg stages the children's tractor derby at our car show each year.

Connie Prather is a bundle of energy, volunteering wherever needed. She is particularly skilled at managing the kitchen during our public events, both in the planning and execution stages. She loves photography and has been helpful in capturing scenes around the county for our website. A former businesswoman in Iberia, Connie has devoted herself to public service; we are grateful she made time for the Miller County Historical Society.

Wanda Wright is last, but certainly not least. A retired Tuscumbia school teacher, she is known throughout the community for her cheerful spirit and encouraging manner. A longtime member of MCHS, she is a knowledgeable docent as well as a willing 'worker bee' when necessary.
