FINDING YOUR BIRTH FAMILY

When searching for your birth family look closely at records and letters in your adoptive family's home. Look for mentions of when or where you were born and adopted. Test your DNA and upload your DNA to multiple databases. This will enable you to find more possible matches.

Other than DNA and home sources, the most reliable set of records available are birth certificates filed with the state. Birth certificates provide the child's original name, name of the mother and sometimes the father, and the place and date of birth. Each state has its own laws about what records are available to the public, who may request the those records and how to submit a record request. Some states have open records, meaning anyone can request them. Other states allow only documented family members to request records. In some states you may need a court order to obtain them. Missouri is among the states that offer limited access to adoption records. For the latest state-by-state information on adult adoptees' legal access to their birth records, see the American Adoption Congress at <www.americanadoptioncongress.org>.

Adoption registries are also a very useful resource. Some are operated by private agencies, some by volunteers, and some are operated by state governments. Some state organizations may only be able to give you nonidentifying information concerning the adoption case you are researching. Laws vary from state to state, but an adult (age 18 and over) can usually access nonidentifying information from the state by making a written request. Identifying information usually requires both parties' consent.

Nonidentifying information gives details about a case that does not include the parties' names. It may include date and place of the adoptee's birth, ages of the birth parents and the reason for the adoption.

Identifying information gives details that could lead to a positive identification of the adoptee, the birth parents, or other relatives. Examples of identifying information include names, addresses, and employment records.

DOROTHY MAY SPEARMAN GREENE

Dorothy Mae Spearman Greene, 96, passed away October 5, 2020 in Minneapolis, Minnesota. Dorothy was born to Fred Spearman and Eunice Hutsler Spearman on June 14, 1924, and was raised in Iberia. Her father was a farmer and also served as the Missouri State Representative from Miller County from 1925-1932 and 1937-1944. She had three sisters, Juanita Dake, Freddie Carroll and Betty Bruemmer. She attended Iberia High School and Iberia Academy. During WWII she supported the war effort working at the Sunflower Powder and Propellant plant in Kansas City with her sister Jaunita and first cousin, Thelma Wall Meredith.

She married William Greene who was stationed at Ft. Leonard Wood near Waynesville during the war. After the war they moved to Minneapolis, Minnesota. She was a homemaker and childcare worker. They had three children, Mary Johnson, Steve Greene (Nancy) and William Greene (Sue). They had seven grand children and four great grandchildren. Upon William's death, she married Morrison Gillet who predeceased her.

In May 2017, Dorothy, her daughter Mary and son William traveled to the Miller County Museum and spent three hours touring the site with Charlotte Graham. We all, but especially Dorothy, enjoyed the visit immensely; reliving so many memories of her life in Miller County.
