Tuscumbia celebrated its sesquicentennial (175 years) with a 'Pig and Pickle Fest' at the Riverside Park Saturday, September 8. The Miller County Museum hosted an exhibit showcasing photos of that area, known as Goosebottom, from the late 1800s and early 1900s featuring businesses and houses no longer in existence. Also included were pictures of the great floods that had caused their

demise. Our featured exhibit was this year's raffle quilt, but we also displayed several older quilts from various community sewing circles. We had a lot of visitors and sold many raffle tickets

Alan Sullivan, consulting engineer for Ameren at Bagnell Dam, presented a power point enhanced history of the construction of Bagnell Dam to our volunteers, board members, visitors and guests Monday, September 24. Because Alan was raised in Tuscumbia, his appearance was a true homecoming. He was uniquely qualified to tell the Lake of the Ozarks story: he not only has been employed with the company for 37 years, but shared personal memories of his Grandpa Elmer Slone and Uncle Lloyd Slone and their work on the original construction of the dam. The lower level of our museum houses a wonderful photo collage of that work which was acquired by a former MCHS president, Wilma Link. Plan a visit to see how Lake of the Ozarks was created!

CHURCH LUNCHEON




Members of Mt. Zion Church

PRESIDENT'S MESSAGE

Walter Stillwell was one of Miller County's most well known and respected attorneys. He died in 1953, but many of his memories, artifacts and historical records were quite well preserved in a large, antique family trunk. This trunk and its contents were recently donated to the museum, along with other items, by his grandson Raymond Stillwell of Alton, Illinois, who is also an attorney. The Miller County Autogram-Sentinel published a 'Windows to the Past' article written by Peggy Hake on May 5, 2011, that chronicles Walter's life:

Walter B. Stillwell was born in Harrison, Ark., June 27, 1879, but came to Miller County and settled in Tuscumbia as a young man. He had studied the law and became an attorney and opened a law office in Tuscumbia with his partner, Jacob Gantt. Later he was in the law profession with Bob Fendorf, his brother-in-law, and their law firm was called Stillwell and Fendorf.

He was active in politics holding several offices including Prosecuting Attorney elected in 1905, 1908, 1910, 1924 and 1928. He was the Public Administrator 1909-1912. In 1930 the Governor of Missouri appointed him as the Circuit Judge of the 14th Judicial Circuit and he held that office until 1933.

Not only was he a busy and successful attorney, but he also owned a partnership in the county newspaper, Miller County Autogram, as co-owner with Lawrence Wright.

In 1932 he was elected as President of the Bank of Tuscumbia and stayed in that profession for over 20 years. He also served as a member of the Tuscumbia school board, the town board and was a member of the Presbyterian Church.

In 1910 Walter bought all the records of Miller County land transactions in the County Recorder's office and began recording all property sales and acquisitions in the county. Later he was joined by his son, Roger Stilwell, an attorney also, and the business was then called Stillwell and Stillwell Abstract Company.

Artifacts donated by Walter's grandson include the door to the Abstract Company which was installed in the lower level of our museum by board member, Jim Clark. The trunk with many of its mementoes and historical documents is now on display in the library area upstairs. We are very grateful to Raymond Stillwell for donating and delivering these items to the Miller County Historical Society.
